
- Prices sag at Australian wool auctions

Prices slid back in the **Australian wool market** this week despite a rather small offering of a little under 25,000 bales. The **Eastern Market Indicator** (EMI) fell by 20 cents to 1272 Ac/kg. Prices for most microns were sharply lower, although there were some brighter spots. Merino wool of 17 micron & finer did better, with prices rising a little. There were some encouraging signs from Fremantle on Thursday with prices for 19 micron & finer wool lifting. The Western Market Indicator fell the least, down by 12 cents for the week to 1358 c/kg. The Northern Market Indicator fell by 18 cents to 1307 c/kg and the Southern Market Indicator was down by 20 cents to 1250 c/kg. The A\$ fell against the US\$ and the Renminbi and was steady against the Euro. As a result, the EMI fell by 26 UScents to 802 USc/kg, fell by 124 RMB to 5697 RMB/kg and was 11€cents lower at 741 €cents/kg.

**Wool auctions** resumed this week in **South Africa**, albeit online and with significant restrictions. The Covid-19 lockdown in South Africa is stricter than in Australia and wool is not regarded as an essential service. Wool is deemed an essential service in Australia. The restrictions in South Africa mean that shearing is permitted, but wool cannot be transported to broker stores, with growers storing their wool on-farm. Traditional open-cry auctions are also not permitted, nor is the testing of wool. The South African Government allows wool to be transported from brokers' stores to port for export. The South African Government very recently permitted wool that was already tested and stored in brokers' stores to be made available for sale. The South African industry did that this week through an electronic auction offering 5,382 bales over two days, of which 87.9% was sold. The next auction is scheduled for 30<sup>th</sup> April.


Global demand for raw wool was weak before much of the impact of the Covid-19 pandemic and travel, social and economic restrictions were imposed. This is illustrated by the trends in the volume of exports from the five major wool exporting countries. As the first Chart of the Week shows, the total wool exports from the five major exporting countries was 10% lower this season to February compared with the previous season. Exports from Australia, Argentina and Uruguay were all lower this season. The largest decline was for Uruguay, down by 34%, while Argentina's and Australia's exports were down by 16% and 15% respectively. In contrast, export volumes

from New Zealand and South Africa were both higher. South Africa's exports were up by 25% compared with this time last year. This is almost entirely due to the resumption of trade between South Africa and China following the ban following the Foot and Mouth Disease Outbreak. New Zealand and South Africa's exports will fall in March onwards as a result of the ban on wool auctions and other transport restrictions.

Looking at imports by the major processing countries, many have seen a drop in the raw wool imports, as can be seen in the second Chart of the Week. Exports of raw wool to China dropped by 11% year-on-year for the eight months to February 2020. Exports to Italy, Germany and the Czech Republic have all seen significant declines this season to date, as have exports to 'other' countries (which includes Korea, Japan, Thailand, Malaysia, and Egypt). India and 'Other Europe' have both recorded modest increases in exports.

due to the Covid-19 pandemic and restrictions. The IWTO Digital 2020 Congress Brussels will feature a limited number of sessions for operational and statutory purposes (such as the Executive Committee meeting, the Contracts & Specifications Technical Meeting and Voting meeting and the Heads of Delegation Council Meeting). There will also be a few working group meetings (Wool Trade Biosecurity, Sustainable Practices and Product Wellness). Attendance will be by a mix of teleconference and videoconference. Meeting dates will be Wednesday, 20<sup>th</sup> May to Saturday, 23<sup>rd</sup> May. The General Assembly will be held in mid-June, with limited in person attendance and mainly by written proxy. As well as the limited attendance meetings, there will also be Powerpoint presentations from a selected number of presenters made available on the IWTO website. I will be doing one Powerpoint presentation as Chairman of the IWTO's Market Intelligence Committee. I will provide details when they are available.
